

Re: Public Records Act Request – Peralta Community College District

Dear Lylah Schmedel,

Please accept this correspondence in response to your Public Records Act (PRA) request sent to the Peralta Community College District (District) via electronic correspondence **on Monday, October 30, 2023**. The District is committed to transparency and full disclosure in response to your PRA.

You requested the following information:

1. A copy of Copies of all leaves of absence request forms or LAR forms for Timothy Thomas from November 2022-October 8, 2023 that include days missed, including LARs or leave requests for both paid and unpaid leave any and all emails, forms, memorandums or other documented

Response #1: The District has records responsive to this request and it is included in this response as "attachment #1".

2. date/time-stamped authorization from Atheria Smith or Jannett Jackson, as district designees per AP 3530, that grant an "exception" authorizing any district employee to have district-defined "possession" of a "weapon" at the "district" as defined by the AP

Response #2: The District does not have records responsive to this request. Authorization has not been granted to any PCCD employee.

3. we request a list of every current and past district employee who has been granted this authorization from January 2021 - present, including the date the exemption was approved and any corresponding operating procedures as defined by the AP Record of any current or past investigations into Thomas' conduct at PCC for any reason (confirmation and number of investigations will suffice)

Response #3: The District does not have records responsive to this request. Authorization has not been granted to any PCCD employee.

4. Record of any district-launched investigation into Thomas' January 30 arrest seeking clarification as to whether he was carrying a "weapon" on "district" grounds (confirmation and number of investigations will suffice)



Response #4: The District does not have records responsive to this request. The District has not launched an investigation regarding matters unrelated to Tim Thomas' employment.

5. A printed copy of the schedules/calendar information of all district-related work activity including meetings, conference attendance, calendar holds, Zoom meetings, meetings off-site or phone conferences for Timothy Thomas, Jannett Jackson and Atheria Smith for January 30, January 31, February 1, February 2 and February 3.

Response #5: The District has records responsive to this request and it is included in this response as "attachment #2".

6. Document copy and/or indication of when a District representative or the district in general was put on notice of Thomas' DUI charges.

Response #6: The District does not have records responsive to this request.

General Objection to Producing Records Exempt

Pursuant to Government Code Section 6255, subdivision (a)

With respect to all of the District's responses above, the District will not produce any records for which the public interest in non-disclosure clearly outweighs the public interest in disclosure, or records which it deems to be exempt pursuant to the "deliberative process" exemption to the Public Records Act (Government Code section 6255, subdivision (a)). Under this exemption, the District may withhold records if the disclosure of the records would expose the District's decision-making process in such a way as to discourage candid discussion within the District and thereby undermine the District's ability to perform its functions. *Times Mirror Co. v. Superior Court* (1991) 53 Cal 3d 1325, 283 Cal Rptr 893, 813 P2d 240, 1991.


