On November 13th 2025, V-1 John Beam was shot while at Laney College in Oakland, CA. He was unfortunately pronounced deceased on November 14th 2025.

Surveillance footage from the incident was reviewed and a potential suspect was identified. On November 14th 2025, a person matching the description of the suspect was detained and identified as S-1 Cedric Irving. He was placed under arrest and transported to Oakland Police CID for interview. A handgun was located in one of the bags in S-1 Irving's possession at the time of his arrest.

During an interview, Cedric Irving was admonished of his rights and acknowledged them before providing a statement. S-1 Irving admitted that the gun located in his bag belonged to him. S-1 Irving admitted to shooting V-1 John Beam with that gun.

Based on the above information, I believe there is probable cause to place Cedric Irving under arrest for the following offenses:

PC 187:

S-1 Irving admitted that he was the person that shot John Beam, which resulted in V-1 Beam's death.

PC 25400:

At the time of his arrest, S-1 Irving was carrying a handgun concealed in a bag that was in his immediate possession. When shown a photograph of the handgun that was recovered, S-1 Irving admitted that the firearm belonged to him.
